**NOTICE INVITING e-RE-TENDERS (NIT)**  
(THROUGH GOP E-TENDER PLATFORM -- <http://etender.punjabgovt.gov.in>)

e-Tenders in a single bid system are re-invited for the disposal of 4 lots ( 3 lots of which are re-tendered) of Longstanding Imported cargoes as mentioned below on “*as is where is and whatever there is basis*” lying at Inland Container Depot (ICD), A-12, Phase V, Focal Point, Dhandari Kalan, Ludhiana.

The e-Tender forms (Non Transferable) containing details of cargoes to be disposed off by the Punjab State Warehousing Corporation (PSWC) and other terms, conditions , Earnest Money Deposits and stipulations are available on website <http://etender.punjabgovt.gov.in> upto 1700 Hours IST till 10.04.2017. Those who download the e-Tender document and submit the same by uploading on the website <http://etender.punjabgovt.gov.in> will have to pay Rs. 1,000/- online towards cost of e-Tender form at time of submission of e-Tenders without which the tender offer will not be considered as valid. For participation, the tenderer/s shall have to get themselves registered with <http://etender.punjabgovt.gov.in> and get the User ID and Password to submit their bid offers online after logging in to their accounts accordingly. For participation in the e-Tendering process, Class III Digital Signature (DSC) is mandatory.

The cargoes of the 4 lots may be inspected at ICD Ludhiana on any working day between 9:00 A.M. to 5:00 P.M.

e-Tenders accompanied by Earnest Money Deposit and cost of e-Tender form shall be submitted by uploading on the website <http://etender.punjabgovt.gov.in> upto 1200 Hours IST on 11.04.2017. The e-Tenders shall be opened at 1500 Hours IST on 11.04.2017 at Head Office, Chandigarh in presence of tenderers or their representatives who may wish to be present. Tenders not accompanied by Earnest Money Deposits and cost of e-Tender forms shall be summarily rejected.
