Sub: Guidelines for disposal of damaged wheat unfit for human consumption for lots not tendered in two or more tenders ...reg

Sir,

Please refer to your office letter on subject quoted above vide which you have sought certain clarification regarding dumping of the damaged/NI stocks, if no offer is received at successive auction/tenders for the stock fit for cattle feed/poultry feed.

In this connection, following facts/clarifications are conveyed -

- 1. In such circumstances, as per compendium of instruction 2013 series-I Chapter 20 clause 20.6, it is stated that "The stocks categorized as fit for cattle feed/poultry feed would form one category for the purpose of auction/tender. If no offers are received for the stocks categorized fit for cattle feed/poultry feed in the auction/tender from the registered parties for this purpose fresh auction shall be held for the same stock where all the registered parties including the parties registered for manufacturing of Industrial Use/Manure shall also be invited. If no offer is received at successive auction/tenders i.e. once as stock declared as fit for cattle feed/poultry feed and secondly as stocks declared fit for other purposes as well, dumping should be resorted."
- 2. Further, as per clause 20.7, it is apprised that "in case of the stocks fit for industrial use, if no offer is received in two successive auction/tenders, dumping is to be resorted to. The stocks fit for manure will be put for tender/auction sale only once, and in the absence of any response, shall be dumped".

However, the contention made in compendium of instruction is meant for internal use of Food Corporation of India, hence tender floating agency has every right to modify their tender as per their convenience and as per financial implications, if they feel so as they are independent financially. Moreover, it is also apprised that the request of State agencies regarding guidelines for recategorization of the said stocks has already been conveyed to FCI higher offices, as and when the same are received, it will be intimated to State agencies.

This is for your kind information and necessary action please.
