

# **INTRODUCTION:**

Punjab State Warehousing Corporation PSWC was originally established in 1958 for the purpose of warehousing of agricultural produce and other notified commodities under the Agriculture Produce (Development & Warehousing) Corporation Act 1956 which was subsequently replaced by Warehousing Corporation Act, 1962. It was declared as one of the procuring agencies in 1993 to procure food grains on behalf of Govt. of India. PSWC is a pioneer in introducing globally accepted concept of containerization in the North. It established its first Container Freight Station-Dry Port, at Ludhiana in 1990 followed by setting up CFS's at Jalandhar (1991), Amritsar (1993) and Bathinda (1995).

# HOW CLIENT'S CAN UTILIZE THE SERVICE OF WAREHOUSES:

- Any citizen (i.e. Agriculturists, Traders, Co-op Societies etc.) can approach the
  Warehouse Centers (115 Centers) and deposit their products in the
  Warehouses. The grains are deposited by filling a depositor form. The
  Warehouse Manager will issue a Warehouse Receipt intimating the commodity
  no's of bags, weight, rate and total value of the stocks. The validity of the grains
  will also be indicated.
- The grains are kept free from infestation by providing regular prophylactic treatment to the grains stored. Storage charges per bag per month will be charged while taking delivery of the stocks as per Schedule of CWC revised from time to time and as adopted by PSWC. The Storage Charges will however differ from Centre to Centre depending on the position of the center. Anybody can keep their notified commodities in the Warehouse.
- A rebate in storage charges is allowed to bonafide agriculturists and it will be admissible only for the storage of their products raised by themselves on their land.
- At times, if the Storage space is not available in the godown, hired godowns are taken to store the excess stocks.
- PSWC has got registered its eight owned godowns of total 18,150 MT capacity under Warehousing Development and Regulation Act 2007 w.e.f 01.05.2012 located in the districts of Kapurthala, SBS Nagar and Jaladhar
- Unloading and Loading of Food Grains through Handling & Transporting
   Contractors is provided to all centers to help the Farmers/Traders/Clients.



## **GRIEVANCES REDRESSAL MECHANISM:**

Any Public grievances can be addressed to the Head office at state level, District Level at District Office and Field level at Warehouse centers.
