- 1.** For inviting EOI Offers/Proposals from eligible insurance organizations, a Public Notice (Press Notice) was published in (a) The Hindu, (b) Rozana Spokesman, (c) The Hindustan Times, (d) Dainik Jagran, (e) Daily Ajit, (f) Arth Prakash and (g) Millennium Post all dated 15.05.2026. Said Public Notice was also hosted on PSWC's website (www.pswc.in) along with detailed instructions, terms and conditions of EOI document.
- 2.** The last date for submission of EOI Offers was scheduled for 29.05.2026, which was extended upto 12:00 NN on 05.06.26 *vide* Corrigendum dated 29.05.2026 hosted on website of Corporation. The EOI Offers as received were scheduled to be opened on same day i.e. 05.06.2026 at 1:00 PM by Committee of the Corporation, in presence of Applicants' representatives who may wish to be present, for scrutiny and evaluation.
- 3.** Upto the closing date, sealed EOI Offers of following 3 applicants were received:
 - a. M/s IFFCO Tokio General Insurance Company Ltd.
 - b. M/s IndusInd General Insurance Company Ltd.
 - c. M/s National Insurance Company Ltd.
- 4.** Upon opening and evaluation of above EOI Offers in presence of Applicants' representatives as per schedule, the Committee made its observations and the deficit information/documents were requested from all applicants *vide* Letters dated 10.06.26 to be rendered by 12:00 NN on 12.06.26, in accordance to Para D (18) of terms of EOI document.
- 5.** The applicants submitted the information/documents which were scrutinized by Committee in reference to EOI Offers of applicants and terms of EOI document. The Committee shortlisted the following 3 applicants as pre-qualified as per the EOI criteria from whom sealed rate quotes have been requested for further consideration:
