- 7. CONWARE can terminate the contract by giving one month's notice or consolidated one month's emoluments in lieu thereof without assigning any reasons whatsoever.
- 8. In case the candidate wish to discontinue the contract, they will also be required to give one month's notice or deposit one month's consolidated emoluments in lieu thereof.
