## **TERMS AND CONDITIONS:-**

- Condemned vehicles can be inspected on any working day at Punjab State Warehousing Corp., SCO 74-75 Sector 17-B, Bank Square Chandigarh & each vehicle will be sold on "as is where is" condition basis.
- The vehicle will be sold at the reserve price (from 02.03.2023 to 16-03-23) on "First Come First Serve" basis & will be allowed to pick the vehicle after full payment + 18 % GST on reserve price (after completion of all other relevant charges) to the following mentioned categories Govt. Employees, retired Govt. employees, Ex-MPs, Ex MLAs, War Widows, MPs and MLAs. All these categories will have the same level of priority.
- For the purchase of these vehicles the persons belonging to reserved categories shall give their request alongwith the draft equivalent to the reserve price in favour of Punjab State Warehousing Corporation (payable at Chandigarh) along with tax /GST extra on reserve price.
- 4. The buyer has to take delivery of the vehicle within 72 hours of the acceptance of his request by PSWC (In case of failure, the deposited money via DD will be forfeited).
- 5. The buyer of reserve category shall furnish an affidavit duly notarized that:
  - a. In case the buyer does not gets the RC transferred on his name within stipulated time the department reserves the right to cancel the RC of the vehicle from resepective RTO.
  - Buyer will submit the transfer documents of the vehicle from the concerned RTA office by the buyer himself/herself with in 1 month form the date of possession of vehicle.

- The RC transfer fees/charges/insurance/GST applicable and any other relevant charges & Govt taxes to be borne by the purchaser.
