### **Terms and Conditions**

1. The term of contract shall be for a period of one year or till regular appointments are made (whichever is earlier).
2. The selected candidate will be paid consolidated emoluments i.e last pay drawn minus pension per month.
3. The applicants should have retired after 01.01.2016.
4. During contract TA/DA will be paid as per State Govt. instructions.
5. They can be posted at any place in the State of Punjab.
6. The Corporation can terminate the contract by giving one month's notice or consolidated one month's emoluments in lieu thereof without assigning any reasons whatsoever.
7. In case they wish to discontinue the contract, they will also be required to give one month's notice or deposit one month's consolidated emoluments in lieu thereof.
8. Their services shall be governed as per the Rules and Regulations of the Corporation as are in force and as may be amended by the Board of Directors of the Corporation from time to time.
9. They will have to submit a self-attested undertaking to the effect that they were never convicted for any criminal offence involving moral turpitude & that you were never dismissed or removed from service or any State Government, Government of India or any State Institution.
