## Terms and Conditions

- 1. The term of contract shall be for 2 years from the date of joining in the Corporation and may further be extended as per the requirements of PSWC on mutually agreed terms.
- 2. You will be paid consolidated emoluments of Rs. 50,000/- (Fifty thousand only) (all inclusive) per month and no other allowance, whatsoever, shall be payable.
- You can be posted at any place in the State of Punjab.
- 4. The Corporation can terminate your contract by giving one month's notice or consolidated one month's emoluments in lieu thereof without assigning any reasons whatsoever.
- In case you wish to discontinue the contract, you will also be required to give one month's notice or deposit one month's consolidated emoluments in lieu thereof.
- 6. The candidate will have to produce the original testimonials at the time of interview.
- 7. Your services shall be governed as per the Rules and Regulations of the Corporation as are in force and as may be amended by the Board of Directors of the Corporation from time to time.
- 8. You will have to submit a self attested undertaking to the effect that you were never convicted for any criminal offence involving moral turpitude & that you were never dismissed or removed from service or any State Government, Government of India or any State Institution.
- 9. This appointment on contract basis is subject to satisfactory Police verification of character and verification of your educational certificates from the University/Institution concerned.
- 10. You will have to execute Bond of secrecy in writing.
- 11. You will have to furnish a surety bond of Rs.5,00,000/- on the prescribed proforma (specimen enclosed) to the effect that you shall be liable to pay any amount due from you on any account including any financial loss suffered by the Corporation owing to your negligence or breach of orders on your part. The responsibility for this amount/loss will be fixed by the Managing Director of the Corporation.
- The appointment is purely contractual in nature and does not confer upon him any right for regularization or permanent absorption in PSWC. He shall not be entitled to any benefit like leave encashment, Provident Fund, Pension, Gratuity, Medical Allowance, Seniority, Promotion etc. or any other benefits available to the PSWC employees appointed on regular basis.
- 13. You will not acquire higher education without getting prior sanction of the Competent Authority and for acquiring higher education leave of any kind will not be granted in the interest of the work of Corporation.
- 14. You will have to produce the medical fitness certificate at the time of joining of duty issued by the Chief Medical Officer/Civil Surgeon of the State Govt. Hospital/U.T, Chandigarh.
- 15. In case, any information submitted by you is found to be concealed/fabricated, your contract shall be terminated immediately without any notice, apart from initiating criminal proceedings against you.
- 16. You will have to produce an affidavit duly attested by the Oath Commissioner or First Class Magistrate to the effect that you have only one living spouse.
- 17. No TA/DA will be paid for joining the duty.
