

Sub.: Revision of storage tariff w.e.f. 01.04.2025 at Central Warehouses .

Sir/Madam,

In reference to this office letter of even number dated 19.02.2025 regarding revision of tariff for FY 2025-26 w.e.f. 01.04.2025, feed-backs were received from few Regional Offices which have been reviewed and the Competent Authority has approved the public tariff for FY 2025-26 taking into account the business scenario, market conditions, existing depositor and commodity profile, market rates, utilization pattern of the warehouse and other relevant factors.

1. All Warehouses have been categorised under **13 warehouse categories**. Two additional categories namely **1250 and 1450** have been introduced to optimize the inter-category tariff and have more tariff avenues.
2. The **Area Basis Tariff** for all existing warehouses has been revised in line with the recommendations of RMs, occupancy of the WHs, Depositors' profile and market rate in the locality. Concept of tariff in each category except 1770 and 1800 has been framed as per the pricing strategy of 0.99 effect.
3. **SDWT** tariff has been renamed as **Area with Inventory Management (AIM)** and its value across all categories have been kept unchanged as 10% higher of DWT tariff. The Warehouse wise category, DWT Area Rates (Gross) in Sq. ft., AIM Area Rates (Gross/Net) in Sq. ft., Bonded Rates (Gross) in Sq. ft. and Fertilizer Rates in MT are enclosed as **Annexure-I**.
4. The **Commodity wise Tariff (Bag Basis)** for all commodities have been **increased by 3%** in line with the WPI and weighment charges are also added to club the weighment charges for warehouses. Due to this inclusion, **NO additional weighment charges** shall be collected from any depositor for storage of stock on bag basis. Besides this, commodity tariff for **Copra & FP Cotton Bales** are kept **unchanged** while commodity tariff of **Mustard/Taramira** is increased by 6% in compensation of revision of Bag Equivalent. **Therefore, concerned Warehouse Managers storing Copra & Mustard/Taramira is advised to store the stock as per revised Bag Equivalent for optimum utilization of storage space and revenue realization.** Commodities, whose tariff was fixed during FY24-25, have been included in the tariff, if any such commodity is not included in tariff, intimation to this office may be done. If any such commodity or any new commodity is received at the warehouses, the proposal for the same may be sent to CO for fixation of storage tariff accordingly. The revised Commodity wise tariff is enclosed as **Annexure-II**.
5. The **Special Commodity Tariff for Farmers & Traders (Bag Basis)** which was issued in the year 2022-23 i.e., dated 14.09.2022 has been **discontinued for FY 2025-26**.
6. Tariff for Weighment Charges other than storage at CWC WHs, Metals storage, Cold Storage

Vashi, Ambad (Nashik) charges has also been revised and attached as **Annexure-III**.

7. Considering the inventory management and extra establishment cost for storing and managing books, the AIM tariff for '**BOOKS**' stored under AIM has been fixed and retained at 36% higher than DWT tariff as per **Annexure IV**.
8. **AIM FUMIGABLE STOCK TARIFF** shall be applicable as per **Annexure V**.
9. In case of utilization on Dedicated Warehousing Terms (DWT) being inbuilt annual escalation clause, the annual escalation of tariff as per the agreement shall continue to be applicable from due date (date of anniversary or financial year wise as applicable).
10. Bonded area tariff shall be applicable only for custom notified warehouses, if any Time Barred bond (TBB)/seized/confiscated cargo are lying in such warehouses those are not custom notified then the storage charges shall be applicable as per AIM rates.
11. **FCI/SCSC Gunny Bales:** Separate bills to be generated for food grain and gunny bales stored within reserved space. The bills for food-grains stored will not attract GST, however, bills for storage of gunny bales in reserved space will attract GST.

For example; at any center FCI/SCSC has reservation of 5000 MT and out of this 5000 MT capacity FCI stored 100 MT of gunny bales and 4900 MT of food-grain, in this scenario the separate bills will be raised for 4900 MT food-grain on reservation rates (without GST) and for 100 MT gunny bales on reservation rates (with applicable GST).

This shall be applicable only where minimum guaranteed reservation period is of 01 year.

12. Tariff with regard to FCI on guarantee basis is regulated by the Ministry, based on recommendations of Chief Advisor Cost (CAC), Ministry of Finance and the same shall be circulated as and when revised.
13. As per the current billing logic in case of General Basis monthly billing depositors, bills shall be generated ACKs wise which has completed 30 days storage as per this office circular dated 02.07.2020. Due to this, logic, stock received on 28th of any month shall be billed after completion of 30 days i.e. 27th of next month. However, to streamline the process and as advised by the IA Division to protect the financial interest of CWC, billing logic has been revised and bills shall be generated in the end of same month, on which stock is received. For example, if stock is received on 28th April, then its billing should be done in billing month of April itself for no. of days stored in that month i.e., for 03 days in this case and for the calculation of day wise tariff, no. of days to be stored divided by 30 days (Month is considered 30 days irrespective of calendar month) multiplied with monthly tariff may be kept.
14. In case of DWT/AIM last billing for part month, per day tariff may be calculated by dividing no. of days by 30 as month. For example, if reservation is valid till 18th August 2025, then in last bill, per day tariff may be calculated as No. of Days for utilization (18)/30 irrespective of calendar month.
15. No rebate may be allowed without approval of Corporate Office except under DoP of RMs. The existing rebate of 10% to Co-operatives/ Agri Start-ups and 30% to Farmers i.e., bonafide agriculturist only for the storage of their products as per Para 7 of CO circular issued vide letter No. CWC-BD/II-Tariff/91 dated 13.01.1992 may be continued. Rebate on account of bulk storage, longer term storage and other special circumstances shall be decided on case-to-case basis with the prior approval of Corporate Office if it is beyond the DoP of RMs. Rebate already offered will continue till expiry of period agreed upon. All other Rebate shall be regulated through rebate policy circulated vide letter no. CWC CO-CD0DEDI/6/2023-COMM dated 08.01.2024.

16. It may be ensured and confirmed that tariff of all the warehouses either Hired or Own under your jurisdiction has been revised and implemented. Further tariff for any other general warehouse/commodity which has not been included in the revised tariff may be brought to the knowledge of CO for fixation/revision. **If any centre has been closed and still appearing in tariff, the same may be intimated to CO.**
17. Storage/MF tariff for CFS/ICD/ICP/ACCs/RWCs may continue to be fixed for each centre depending on its location, availability of business and quantum of competition. However, RM may send the proposal for revision of tariff if not considered/revised already. Under no circumstances the existing tariff will be continued beyond 01.04.2025 without CO approval.
18. Goods and Service Tax/any other tax as levied by the Central/State Govt. or local bodies, if any, will be charged extra wherever applicable, in addition to storage, insurance charges etc.
19. RM should bring out a booklet containing tariff for various warehouses/commodities in the Region and may communicate to concerned Warehouses/Depositors. It should also contain general terms and conditions for storage/delivery etc.

It is advised to re-check the revised tariff and intimate if there is any disparity so that the same may be reviewed at the Corporate Office. It is also directed to strictly implement the revised tariff and monitor its impact on the income of the centers.

Please acknowledge the receipt of this letter and bring the revised tariff to the notice of all concerned Depositors/Customers in your region for implementation.


